CK asked if there were any questions or comments.

LC said that we need to think about language as we can set the tone for the language. LC provided an example in respect of somebody taking her Instagram account and when she tried to report it, nobody was interested and this raises anxiety in that somebody can use your details/identity.

CK provided a link to her website in the chat <u>www.childrenandtech.co.uk</u> and advised the group that there was a lot of information on it.

CK advised the group that she had carried out some research with children and their parents (6,500 children and 1,500 parents) and only 30% of parents were concerned for their children which raised the concern that people don't understand this space.

El asked the group to think about the following:

- What do we need to do collectively?
- Who is missing from this group
- What do you already know, what would you like to know?
- What do people know about, what do we already use?
- How can we make a difference?

CK advised that the online safety bill was correct as yesterday (08/09/2022) but with the new government Liz Truss, is now changing which highlights how quick things move. The passage of the bill will now be, at the earliest, 2025.

CK suggested that we need to think about:

- Websites within West Yorkshire
- User to user spaces
- Needs to be in education settings
- Client software
- Internal intranets
- Software that communicates
- Policies/guidelines for personal use
- Phone/email and working from home
- GDPR
- Social focus for children

LB suggested that perhaps we could work on ethical guidance.

The group discussed what concerns people the most.
